This execution petition is coming on today for final hearing before me in the presence of **Sri. :: O R D E R ::

- This Execution Petition is filed for attachment of movables of Judgment Debtors 1 and 2 Under Order XXI Rule 43 and for proclamation and sell Under Rule 66 and 64 of CPC for realization of the decretal amount.
- 2. The brief avernments of the affidavit filed along with the petition by the Decree Holder is that after passing of the Award on 19.11.2019 the Decree Holder approached the Judgment Debtors for payment of the decretal amount but they did not pay the same. Therefore requested the Court to pass the orders for attachment of schedule mentioned movable properties against Judgment Debtors 1 and 2 Under Order XXI Rule 43 of CPC.
- 3. The $1^{\rm st}$ Judgment Debtor filed counter. The Notice of Judgment Debtor No.2 unserved. The brief avernments of the counter filed by the $1^{\rm st}$ Judgment Debtor are that the Judgment Debtor filed

Counter by stating that he is not having any immovable properties and that he has not sufficient means to maintain house and to discharge the alleged debt and and he is unable to pay the debt amount. Therefore requested the Court dismiss the E.P.

- 4. At that stage, the Decree Holder through the Learned Counsel filed a memo stating that the Decree Holder Company not pressing the Execution Petition at present. Heard both sides. Perused the record. The memo filed by the Decree Holder is recorded.
- 5. In view of the discussion as taken up above, it is the evident that the Decree Holder company is not pressing the E.P against the Judgment Debtors hence the Execution Petition is liable to be dismissed as not pressed.
- 6. **IN THE RESULT,** the Execution Petition is dismissed as not pressed, without costs.
