XXXXX by Sh. Manjinder Singh Brar, counsel for accused.

I had not made any inquiry from any other inmate confined with accused Pooja Mahajan at the relevant time in burail Jail, Chandigarh to ascertain whether any checking as alleged was conducted or not. I did not inquire from Meena Kumari and Kiran Gupta regarding the presence of any other person at the time when they conducted the alleged search of Pooja Mahajan. It is also in my active knowledge that in a single barrack multiple inmates are present. Even as per the information supplied to me by the jail authorities accused Pooja Mahajan was not in solitary confinement and as such number of other inmates must have been presented at the time of conducting the alleged search. I had not given any notice u/s 91 Cr.P.C for production of CCTV Footage to cross verify the version put before me by the jail authorities. Vol. The jail authorities does not provide such footage due to security reason. I had not recorded the statement of any witness to the fact that what was the movement of accused Pooja Mahajan prior to the alleged recovery. I had not taken on record any warrants received in jail from different courts regarding the movement to secure the presence of accused Pooja Mahajan in the court. I had not made any inquiry as to how as per the version of the jail authorities the mobile phone entered the premises and I had not recorded any statement of any witness in this regard. Vol. It was the duty of lady police official who was the second IO. Only the lady second IO can disclose inquiry or not. It is also correct that Santari duty at the entry post are both male or female officials and there is no discrimination in marking the duty. As a gen-

eral rule I am aware of the fact that when an inmate enters the prison he is thoroughly checked. I do not know that Pooja Mahajan had already filed complaints against the jail authorities and lady warden in jail for harassment and discrimination and unnecessary putting of pressure. I had not conducted any investigation in this regard. I had not conducted any preliminary investigation whatsoever and I believed whatever was told to me by the jail authorities. It is incorrect to suggest that a false case has been plated upon the accused i.e. why no independent witness was joined in the investigation despite easy availability. It is further incorrect to suggest that the false case has been planted upon the accused as the jail authorities were harnessing grudge against Pooja Mahajan due to the complaints filed by her and her bold behavior against discrimination in the jail. It is further incorrect to suggest that I am deposing falsely.
