Arguments heard on the bail application of accused A-21 Kamil.

Ld.Addl.PP for State has not disputed this fact that accused A-21 Kamil was earlier on bail. In the facts, **the application filed is allowed and accused A-21 Kamil is admitted to fresh bail on his furnishing a personal bond in the sum of Rs.10,000/- with one surety in the like amount. Bail bond filed. Same stands accepted.**

Today, it is submitted by Ld.Addl.PP for State that he is unable to lead arguments as the police file has not been received from the previous court. Accordingly, he has made a prayer that notice be issued to the IO Inspector / ACP Keshav Mathur as police file is not with the prosecution branch as per inquiry made by him.

**Also, issue NBW against accused A-9 Firoz and A-36 Rafat Satlewala through IO with notice to their surities for 16.12.2023 for 12 noon.**
