**CHARGE**

I, B.Pushpanjali, B.A., LL.M., 1<sup>st</sup> Addl. Dist. & Sessions  
Judge, Chikkamagaluru, do hereby charge you:

1. Suresh T.S. S/o Satyanarayana, Aged about 46 years, R/o 2<sup>nd</sup> Main, 6<sup>th</sup> Cross, MES Road, Muthyala Nagara, Bangalore-54.
2. Yashas S.A., S/o T.S. Suresh, Aged about 19 years, student, R/o 2<sup>nd</sup> Main, 6<sup>th</sup> Cross, MES Road, Muthyala Nagara, Bangalore-54.
3. Anitha W/o T.S. Suresh, Aged about 45 years, housewife, R/o 2<sup>nd</sup> Main, 6<sup>th</sup> Cross, MES Road, Muthyala Nagara, Bangalore-54.
4. Sushilamma W/o Sathyanarayana, Aged about 65 years, Housewife, R/o 2<sup>nd</sup> Main, 6<sup>th</sup> Cross, MES Road, Muthyala Nagara, Bangalore-54.

as follows:

That on 29.01.2023, when CW2 Venkatesh was working in  
garden bearing Sy.No.46, situated at Hosuru village, Koppa taluk,

coming within the jurisdiction of Koppa Police Station, you accused No.1 to 4 in furtherance of common intention, you accused No. 1 to 4 abused CW1 in filthy language and thereby insulted him and provoked him to commit breach of peace and thereby committed the offence punishable under Section 504 r/w Section 34 of I.P.C., and within the cognizance of this Court.

2. That, on the aforesaid date, time and place, you accused No.1 to 4 in furtherance of common intention and in the course of the same transaction, you accused No.1 assaulted CW-2 with iron rod on his left hand and caused bleeding injuries and you accused No.2 assaulted CW-2 with chopper on his head and caused grievous bleeding injuries to CW.2 and thereby committed the offence punishable under section 326 r/w Section 34 of I.P.C., within the cognizance of this Court.

3. That, on the aforesaid date, time and place, you accused No.1 to 4 in furtherance of common intention and in the course of the same transaction, you accused No.1 to 4 with an intention to commit the murder of C.W.2, you accused No.1 assaulted CW-2

with iron rod on his left hand and caused grievous bleeding injuries and you accused No.2 assaulted on the head and caused grievous bleeding injuries to C.W.2 with such intention and under such circumstances that if by that act, you had caused the death of C.W.2, you the accused would have been guilty of murder and by the said act, you had caused grievous injuries to C.W.2 and thereby committed an offence punishable under Section 307 R/w Section 34 of I.P.C., within the cognizance of this Court.

4. That, on the aforesaid date, time and place, you accused No.1 to 4, in furtherance of the common intention and in the course of the same transaction, criminally intimidated CW2 by giving life threat to him and thereby committed an offence punishable under Section 506 r/w Section 34 of I.P.C. and within the cognizance of this court.

5. That, on the above said date, time and place, you accused No.1 to 3 not being the members of Scheduled Caste or Scheduled Tribe and accused No.4 being the member of Scheduled Caste or Scheduled Tribe, intentionally insulted CW2 Venkatesh, member of

Scheduled Caste, with intent to humiliate him within public view, by abusing him by touching the name of his caste, and thereby committed the offences punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

6. That, on the aforesaid date, time and place, you accused No.1 to 3 not being the members of Scheduled Castes or Scheduled Tribes and accused No.4 being the member of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 323, 324, 354, 504 of I.P.C. against CW2 knowing that he is the member of a Scheduled Caste or a Scheduled Tribe and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
