ORDER BELOW EXH.11 IN SESS. CASE NO. 111/2024

The State of Maharashtra Vs. Parmeshwar (dt. 10th December 2024)

This is application by **accused** No.1/applicant an Parmeshwar Keshav Dhumal, for granting delivery of vehicle i.e. "Hero Splendor+ motorcycle bearing Registration No. MH-26-CB-No. HA11EDN5C54697, 7175. Engine Chassis No. MBLHAW120N5C13997" which is seized by Limbgaon Police Station, Nanded, Dist. Nanded in Crime No.11/2024 for the offences punishable under Sections 307, 294, 506 r.w.s. section 34 of I.P.C. The applicant contends that he is registered owner of motorcycle. He further contends that the vehicle is standing in the open space of premises of the police station Limbgaon and there is every possibility of damage to it and therefore custody of vehicle be given to him temporarily.

- 2- The investigating Officer has filed say (Exh.15) and resisted the application on the ground that the applicant may sale or change the said motorcycle. Hence, application may be rejected.
- 3- After going through the documents in the form of photo copy of vehicle particulars, copy of invoice, copy of insurance policy and Aadhar card of applicant, the same discloses name of the applicant as registered owner of the vehicle. No

purpose will be served by keeping the vehicle in police station. Therefore, applicant is entitled for temporary custody of the vehicle as prayed. Hence, following order,

ORDER

- 1) Application is allowed and disposed off.
- 2) The seized property i.e. "Hero Splendor+ motorcycle bearing Registration No. MH-26-CB-7175, Engine No. HA11EDN5C54697, Chassis No. MBLHAW120N5C13997", in Crime No.11/2024 of Limbgaon Police Station Nanded, District Nanded, for offences Under section 307, 294, 506 r.w.s. 34 of I.P.C., is hereby released on Supurtnama in favour of applicant Parmeshwar Keshav Dhumal, on executing indemnity bond of Rs.1,00,000/- subject to conditions that :
 - i) The applicant shall produce the said vehicle in the court as and when required.
 - ii) The applicant shall not transfer or dispose of the said vehicle in any manner without permission of the Court.
 - iii) The applicant shall not use the vehicle in commission of any offence in future.
- 3) Indemnity bond be given before police.
- 4) The concerned investigation officer of Limbgaon police station is directed to take photographs of the said vehicle from all four angles and submit the same with detailed panchnama about it in Court.
