<b>30.04.2024</b>	<p>CR put up.</p> <p>Accused persons Imliakum Longkumer, M Tuanbiaklian Guite and Shri Jahangir Alom are produced via VC from Jowai Prison today and on being asked accused Imliakum Longkumer and Shri Jahangir Alom are healthy and fine.</p> <p>Seen the medical status report of accused M Tuanbiaklian Guite dated 30.04.2024 issued by Dr. H. Wann M&amp;HO, DP&amp;CH, Jowai stating that the accused is suffering from Grade-IV non-thrombosed external haemorrhoids. He was referred to NEIGRIHMS for further medical investigation on 22.04.2024. At present, the accused is under medication as prescribed by the M&amp;HO NEIGRIHMS and he is under observation by the M&amp;HO, DP&amp;CH, Jowai. The District Prison Authority has informed the Court that they cannot provide attendant to the accused due to shortage of staff as the prison has only one medical attendant (wages) who attend and escort the prisoners to different hospitals as referred by the M&amp;HO,</p>
