Order:

1. This order of mine shall dispose off an application for furnishing better particulars.
2. Brief facts of the present application is that the plaintiff has claimed the relief of mandatory injunction directing the defendants department to pay the mesne profits against the estimate costs of the said work and to release the earnest money with interest but plaintiff has not disclosed in his plaint that how much amount of earnest money has been deposited by the plaintiff with the

defendant trust. It is further submitted that plaintiff has also not disclosed the costs of said work executed by the plaintiff and lastly prayer was made to allow the application and to direct the plaintiff to furnish the better particulars.

2 Upon notice, written reply filed in which respondent took preliminary objection that present application has been filed just to delay the proceeding. On merits it is submitted that entire record of the work in original is lying in the office of the trust and even otherwise all the documents have been placed by the respondent/ plaintiff on file. All other pleadings are denied by the defendants parawise and lastly prayer was made for the dismissal of the application.

4. I have heard both the counsels for the parties and gone through the case file minutely.

5. Present application has been filed by the applicant to furnish better particulars regarding the earnest money paid by the plaintiff. Perusal of the pleadings of plaintiff reveals that how much earnest money was deposited by the plaintiff to the defendant trust was not mentioned by the plaintiff in his plaint. Therefore present application stands disposed off with the direction to the plaintiff to file better particulars. Better particulars filed and supplied. Now to come up on 20.12.2018 for filing written statement.
