Examination-in chief

On 23.12.2022 I was posted at Kalyanpur PS in the post of Sub-inspector. On that day, the complaint was received by Tapas Malakar I/c inspector and after registering the FIR the case was endorsed to me for investigation on 23.12.2022. in course of investigation I visited the PO, prepared the hand sketch map which on identification is marked as **Ext. P-1/ Pw-2** and my signature as **Ext. P-1(a)/ Pw-2**. I prepared the separate index of the PO which on identification is marked as **Ext. P-2/ Pw-2** and my signature as **Ext. P-2(a)/ PW-2**, recorded the statement of available witnesses U/s0 161 of Cr.P.C, issue notice upon the accused person U/s-41 A of Cr.P.C., collected two injury report of two victims from Kalyanpur CHC. After completion of investigation finding the prima facie materials against the accused person namely Binoy Debroy submitted charge sheet vide No. 52 of 2022 dated 31.02.2022 U/S- 323/379/506/34 of IPC.

The accused person against whom I submitted the charge sheet is not present at the dock today. Had he been present I could identify him easily.

Cross-examination

It is a fact that it reveals in my investigation that the complainant is an home tutor but it is also a fact that in the complaint petition the complainant wrote his designation as member of SFI.

It is a fact that I have not investigated specifically to the pointed the complainant was engaged in home tuition to which student and which particular student paid the fee on 23.02.2022 and the same fee paid to the complainant was stolen.

It is a fact that during investigation and on perusal of the injury report it was written that no external injury sustained by the complainant and another person.

It is not a fact that it has revealed in my investigation that the complaint was filed out of political rivalry.

It is not a fact that my investigation is perfunctory.
